Information on introduced Legislature bills: SB 21-062 has to do with changing various things about when a police officer can arrest someone, management of jail population, and doing away with cash bail for a number of crimes. The full bill can be read at https://leg.colorado.gov/sites/default/files/documents/2021A/bills/2021a_062_01.pdf. Here is a brief explanation of the different crimes in the bill.

Class 4 Felonies—Class 4 felonies are punishable by two to six years' imprisonment, a fine of between \$2,000 and \$500,000, or both. Theft of property worth between \$20,000 and \$100,000 is a class 4 felony. (Colo. Rev. Stat. § 18-1.3-401 (2019).)

Class 5 Felonies—Colorado's laws impose a sentence of one to three years in prison, a fine of \$1,000 to \$100,000, or both, for a class 5 felony conviction. Forgery, for instance, is a class 5 felony. (Colo. Rev. Stat. § 18-1.3-401 (2019).) Class 6 Felonies—Class 6 felonies are the least serious felonies in Colorado, punishable by one year to 18 months in prison, a fine of \$1,000 to \$100,000, or both. For example, impersonating a peace officer is a class 6 felony. (Colo. Rev. Stat. § 18-1.3-401 (2019).)

Drug Felonies—Level 3: Two to four years in prison, between \$2,000 and \$500,000 in fines, or both.

Level 4: Six months to one year in prison, a fine of between \$1,000 and \$100,000, or both.

Members present: Steve Wall/Vice President, Donna Snyder/Treasurer, Ike Nelson/Secretary, Wade Hancey/Special Projects, and Dave Padilla/Parks Manager.

Public Comments - Tom Bryant said he has been to Clement Park and noticed that their bathrooms were locked for the Winter because of the cold and therefore building permanent bathrooms at Weaver and Leawood Parks would not be a good idea as previously recommended. He also is concerned about snow plowing in Raccoon Park possibly causing damage to the wooden bridge. Dave actually hand shovels the wooden bridge to protect it.

Treasurer's Report - Donna presented the Treasurer's Report, bills paid this month include: Denver Water, United Site Services, doggie bag vendor, Waste Management, Xcel Energy, Melendrez Gutters, Rich Alarcon, Dave's invoice, reimbursement to petty cash and Ike was reimbursed for budget publication.

Parks Manager Report - ATV repaired. Snow removed in all Parks. All parks were inspected, and doggie bags checked and replenished as needed. Leawood Park: Melendrez Gutters completed the installation of new gutters on the Leawood Park Pavilion. The new park benches should be delivered in the next few weeks. Dave will coordinate with board members for the removal of old benches.

Old Business: (1) Website: Mindi is checking on possible Domain names. Board will need to approve the Domain name. Work will begin on the Website after that. (2) Porta Potties: Wade is coordinating with Liberty Waste Management to replace the current vendor. 
Laurie will put an article in about the decorating contest.
