No one from **Jefferson County Sheriff's Department**, **Jefferson County Public Schools** or **Foothills Parks and Recreation District** was present.

At the last **Foothills** meeting, they discussed budgets. There was a presentation by Jovial Projects. They seemed well organized. Food was given to Food Banks. They discussed Weaver Hollow at C-470 and W. Simms. They are involved in the community. They discussed golf fees for the golf courses. The average cost is \$61. The new board member was present. They will finalize the budget in December.

Colin will pass on the Maureen's letter to Ron with **Foothills Parks and Recreation District.** They have applied for a the grant from Jeffco Open Space for that proposed trail connection near Sledding Hill park.

We had no speaker.

We do not have a President.

Roll Call was taken. We had 5 members present and did not have a guorum.

Ray Moore, Treasurer, said that we have \$591.62.

Cheri Paavola, Secretary, was present. The October minutes were not approved due to lack of a quorum.

Diane Suchomel, Vice President, was present.

Jefferson County Information: CMT 25-126745 is for 5641 Deframe St. They want to rezone from R2 and PD to Industrial-3. This will allow light industrial / office / Warehouse uses. It is the Intercessors of the Trinity west of C-470 and north of W. Bowles Ave. They said that they would pave the street.

PA 25-125507 is for 11852 Schaffer Dr. It is a site development plan for 60 light industrial units, warehousing, and personal storage.

RDP 25-125661 is for 11262 W. Patterson Place. It is a registered distressed property.

RZ 25-124994 is for 6609 S. Yukon St. They want to rezone from PD to R-1C for a subdivision of up to 6 single family homes. It is currently a shopping center in Woodmar Subdivision.

SU 25-124378 is for 6004 S. Kipling Pkwy. The Redemption Hills Church has applied for a special use application. This was previously the Elvis Theater.

The P & Z website has released the draft for STR. A PC hearing and BCC hearing has been scheduled for 11/12 and

12/1 respectively. The company that will manage STR is Vacation Rental Services. They expect to take 7 days to remove web lists that are not approved. Then they will notify the county. They will not start out issuing fines. They will try to educate first, then begin issuing fines at some time in the future. The fines for the first offense are \$500. For the second offense it is \$1,000. Plus, there are daily fines. Who gets the money? It goes into the General Fund. The company is paid based on fees collected. They expect it to take effect in 2026. Diane asked everyone to read up on the STR draft. Also always check the agenda shortly before the date to check for changes. Please attend one of the hearings. The draft excluded hotels and apt. buildings.

The Adopt-A-Highway trash pick-up was on Oct. 19th. Diane thanked Ray for his help for our 19th year on this project. Columbine Library has been reserved for Dec. and Jan.

DCV History: The Story of Our Tennis & Multi-Sport Court — When the DCV Recreation Center was first built, it featured four asphalt tennis courts. Asphalt was the economical choice at the time, but in Colorado's harsh freeze-thaw climate, cracking is inevitable. Over the years, the courts deteriorated to the point that some had to be locked and closed for safety. During the facility upgrade in 2006–2007, the easternmost court was removed and replaced with the grassy area visible today. Between 2011 and 2016, the remaining courts were patched several times, but each winter brought the cracks back. In 2017, the HOA made a major investment to rebuild the east and middle courts using post-tension concrete — the gold standard in tennis court construction. This system uses tensioned steel cables to keep the slab under constant compression, resulting in superior durability and resistance to cracking.

To expand their appeal, one court was retained for tennis, and the other was converted into a multi-sport court featuring basketball, hockey, a hitting wall, and even four-square. Additional lines were also added for junior tennis and pickleball. Since reconstruction, the courts have remained in excellent condition and require minimal maintenance.

Resurfacing is typically needed every 5–10 years, and the Board anticipates funding this in 2027.

In the meantime, minor repairs continue – such as adjusting gate springs and addressing a broken west gate lock, currently secured with a temporary chain. Please remember to close the gates behind you when leaving to keep the courts secure and prevent unnecessary wear on the surface.

Important Reminder: No bikes, scooters, skateboards, or dogs are allowed on the courts. Please also avoid using shovels to clear snow, as they can damage the playing surface.

Thanks to these improvements, our neighborhood courts continue to provide a safe and fun place for families to enjoy recreation close to home.

From Leawood Metropolitan Recreation And Park District Minutes – Thursday, Oct 8, 2025, The meeting was called to order at 6:02 p.m. by President Carole Gottlieb. Board Members Present: Carole Gottlieb (President), Jesse Opgenorth, and Zack Sack. Others Present: Ken Leaf (Park Manager), Judy Anderson, and Vicki Graves.

ADMINISTRATIVE ITEMS Treasurer's Report (Carole Gottlieb) The Denver Water bill for September was noted as being higher than in any previous month.

The Board is awaiting the signatures of Carrie and Kyle to finalize the 2024 audit.

New bid for dog waste pickup services that is anticipated to reduce current costs by 40%.

PARK MAINTENANCE AND OPERATIONS Public Comments— Weaver Pavilion Electrical Outlets: Jesse Opgenorth reported that the electrical outlets at the Weaver Pavilion require locks. Motion: A motion to purchase two combination locks for the Weaver electrical boxes passed 3-0.

Graffiti: The ongoing issue of graffiti under the bridge was discussed. Park Manager Ken Leaf was tasked with investigating anti-graffiti paint solutions.

Park Manager Report (Ken Leaf) Rebar was cleared and collars were removed. Dog waste stations were cleared and serviced. The Benton flower bed was cleaned up, and the purchase of mulch was approved. New timbers for the playground swing set were installed by Brother's Landscape. A resident, Sheridan T-Trac, emailed the District regarding soggy turf and expressed interest in splitting the cost of replacement trees.

CAPITAL PROJECTS AND LONG-TERM PLANNING Trees, Dams, and Stream Management (Zack Sack)

Zack Sack is including commercial arborists in the search process for a replacement firm for Cox Landscaping Two arborist reports were received from Jeffco, both identifying major issues due to a lack of tree care, necessitating significant

removal, trimming, and replacement.

Another large tree fell along Weaver Park and has been removed. The Board plans to move quickly on the removal of compromised trees and to implement a replacement plan. Significant costs are anticipated, with an initial estimate of \$200,000+. Initial arborist meetings revealed conflicting views on which trees to remove. Zack Sack will schedule meetings with both maintenance/arborists for a final determination.

Sprinkler Systems (Zack Sack, Steve Wall, Vicky Graves) Year-to-Date (YTD) irrigation costs are more than double the prior year's costs. A complimentary audit of the Weaver system by Resource Central noted major issues. The Board will collaborate with the new maintenance firm to determine necessary upgrades. Steve Wall and Vicky Graves will research potential grants or awards available to fund the system upgrades.

Beds and Signs (Judy Anderson) New signs detailing rules and prohibitions for the tennis court have arrived. Judy Anderson will continue her bed improvement plan in the spring. Will from Creekside Gardens has offered to provide free design plans.

Insurance and Claim (Carole Gottlieb) Carole Gottlieb completed a full review of the insurance package with the agent (CSD). The Board unanimously agreed that an insurance claim is warranted. A successful claim would help offset the estimated \$200,000+ needed for dead tree and shrub removal and replacement. The claim is scheduled to be filed in Q4 2025.

Maintenance Firm Replacement (Zack Sack) Zack Sack is currently scheduling meetings with Sundown by Design and Lawncare Solutions as candidates to replace the former firm.

From Notes From The September Board Meeting Happy Leaf Season. As we have lost daylight savings and enter the hibernation season, the board has settled into a slower pattern of daily work. We do want to remind everyone that one last landscaping task remains – fall cleanup. As you assess your yard and the work required to get cleaned up, please remember the following: blowing leaves or yard debris into the street is not helpful to the neighborhood or our watershed systems; Waste Connections allows for additional yard waste/trash to be set around your blue trash bin for the month of November; as always, we ask that you attempt to fit as much as possible into your provided bin before relying on street placement of trash.

Please check your mail, the 2026 proposed budget has been provided to all residents. The board remains committed to ensuring we are stalwart managers of our dues, reserve funds and to align to our collective commitment that Woodbourne remains a premier neighborhood. As the snow is likely to start to fall, please be cognizant to ensure your sidewalks and driveways are cleared in a timely manner after each storm. In some cases, teenagers and neighbors can be leveraged for homeowners that require help. If you do require assistance, please reach out to a board member or support@accuinc.com and we will ensure your address is aligned to a resident or board member that can assist. The board will be reviewing and ensuring we are consistent with guidelines around permanent lighting being adopted by a few residents currently.

Please be aware that any permanent alterations to your residence DOES require an Architectural Change Control form to be filled out. We will be developing a dedicated form that allows for quick submission with the relevant requirements to be collected. We appreciate your patience and compliance.

A reminder that you may have up to two (2) political signs or postings in your yard. No resident may adhere any signage to their home or fencing. Signs may be placed prior to voting day but must be removed within 5 days of voting. If there are specific questions, Woodbourne has developed a document that aligns the rules and regulations posted on the Woodbourne online portal.

Please continue to check the social calendar for current events. The Woodbourne Wave has once again offered to produce the Holiday Hayride on December 13. They will ensure that everyone has a festive time and can enjoy community bonding with other residents. 
