Foothills Board moves forward with Mill Levy Election Foothills Park & Recreation District will be placing a question on the November 2014 ballot that would ask voters for an increase in the mill levy rate. The District would use this additional revenue to: Fund critically needed capital repairs and capital equipment for existing parks and facilities; Offset increasing operational costs for current programs, parks and facilities; Improve park maintenance and athletic field conditions; Leverage private, local, state and federal grant funds that require a funding match.

Mill Levy election failures in 2006 and 2008 have resulted in the District implementing efficiencies to continue to provide services to the community. The mill levy rate for operations has only increased twice in the last 32 years: in 2000 and 1982.

Many Foothills parks and a few facilities are more than 30 years old and in need of significant repair. Funds will only be used to update and enhance existing facilities, parks and trails. In many cases, the proposed capital repairs can result in operational savings through more efficient systems, allowing for less need of repairs for an aging infrastructure.

If a 4 mill increase question is approved by District voters, the new tax would be applied to property taxes starting in 2015, and would generate approximately \$3.7 million annually.

A voter approved mill levy increase would result in additional property taxes of about \$2.65 per month per \$100,000 of a home's actual market value.

Please exercise extreme caution when it comes to anything that could start a fire and be aware of all fire restrictions.

I would like to remind everyone that there is a way for us to be informed by telephone of an eminent danger in our community. The Jefferson County Emergency Communications Authority Board has an alert system to notify you by phone of impending danger. You can verify that your land line is registered with the Jefferson County Emergency Communications Authority Board by checking Jefferson County's website. You may also registrar your cell phone numbers at this same website.

At the Jefferson County Sheriff's website there is additional information about Smart911 which is another service available to Jefferson County residents. This is a free service where users create a safety profile by entering vital data they want made available about themselves, family, residence and even pets. Data given can include photos, and information regarding medical conditions, allergies, disabilities and/or special needs, home addresses of cell phone callers and floor plans to name a few. Smart911 delivers this information automatically to dispatchers, who then enable responders to be more successful with access to critical health and logistical information before arriving at the scene of

From Leawood Metropolitan Recreation and Park District Minutes July 9, 2014 The meeting was called to order at 6:35 PM at Leawood Park by President Kyle Sargent. Members present were: Donna Snyder, Linda Smith, Charlie Campbell, and Dave Padilla, Parks Manager. The following residents were present: Kathy and Mark Lane, Debby Baker, Ike Nelson, Will and Beth Narva and Alisa Long.

Public Comment- Residents in attendance wanted to discuss the party event on June 14 and what could be done to prevent the problem again in the future. They stated that the volume of parties has increased and so has the attendance. The party on June 14 resulted in the Sheriff's Department being called. It was estimated 100 late teens and adults were at the park with speakers and alcohol. Lots of trash was left and with the porta potty being filled, public urination was taking place in the bushes. The Board was unaware of the event until Dave and Kyle were called. They called the Sheriff's Department also and Dave stayed until all party goers left the park. (Reminder: Do not attempt to disperse party people. Call the Sheriff's Department.)

A lengthy discussion took place with suggestions of solutions to help with the volume and noise. Suggestions included: directing the Sheriff's Department to enforce the current park rules, changing current park rules to eliminate alcohol, setting a permitting system for pavilion reservations and limiting the number of people in the pavilion at one time, charge for pavilion use and have reservations only, limiting the time to 2-4 hours for pavilion use, setting a time for the pavilion to be shut down in the evening, more signage and bigger signage in the pavilion area.

The issue will be discussed at the August 13 meeting with rules and use decided on. Any suggestions or other thoughts, please contact any of the Board members. A resident asked for a list of telephone numbers to call for the Sheriff and others to be published in the Rappporter each month. Also a resident asked for investigation on having a light put in at the corner area of Raccoon Park - approximately Leawood Drive and Sheridan.

The Civic Association asked the Board to reserve the Leawood Park pavilion for Saturday, August 23 for the annual picnic.

Treasurer's Report – The Treasurer's report was submitted by Donna. Property tax revenue, ownership tax revenue was reported. Invoices for the month include: L & M for contract grass cutting, doggie bag vendor, Waste Management, United Site Services plus extra service clean for the unexpected party in June and potty in the creek, DBC for irrigation supplies, Denver Water, Silver Sage for trees, Leawood Civic Association for Rappporter fee and donation for one of the dumpsters for the Leawood Clean-up Day, Xcel, Dave's invoice and reimbursement to petty cash. Linda moved the report be accepted and bills paid. Charlie seconded and the motion passed.

Parks Manager Report – Work in Raccoon Park should be completed by the end of July, if not sooner. The irrigation line for the new trees has been completed and six new trees have been planted. (Be sure to stop by and look at the area.) Stumps have been ground as needed and the safety trim is almost complete.

Kids pulled the porta potty out at Weaver Park and rolled it down the hill. United Site Service was called to clean up the messed up potty. A date has been set to cut the weeds in the triangle area adjacent to the Good property. General irrigation and maintenance work was done by Dave. Five new trees were planted in Weaver Park in two locations plus replacing one dead tree. Doggie bags were checked and replenished. Dave and L&M crew cleaned up the mess left by a party on June 14. Native grass was cut.

Old Business – Projects: The Project list was reviewed and updated with the new items and a few corrections made.

New Business – Park use/lease criteria, rules - We will finalize the park use rules at the August 13 meeting based on

discussions by residents and Board members.

Heather presented an example of the new Leawood Welcome Basket. The board discussed the need for information, including more local businesses, road maps, bike trails, and more. Mike will look at Café Press items, which could be provided from the LCA, to include in the basket. Lori will look into including information from Leawood Elementary School. The board decided to reimburse Heather for up to \$10/ basket, in order to purchase all needed items.

The board discussed the following events; the success of Bulk Clean-Up day, Front Yard Parties (FYP's), and the annual picnic (Aug. 23). Rhonda reported that approximately \$450 was collected on Clean-Up day, and the neighborhood filled three 30 yd. dumpsters! Mike presented the new FYP signs for the neighborhood.
