The meeting started at 6:00 p.m.

Diane Suchomel, Vice President, welcomed everyone.

Our Aug. 1 Picnic was at 6:00 p.m. at Shelter 6. The candidates present were Peggy Catlin / RTD District N incumbent, Casper Stockham / Congressional District 1 candidate, George Stern / Clerk & Recorder candidate, Annette Cannan/ Jefferson County Coroner candidate, Scott Kersgaard / Jefferson County Assessor candidate, Lesley Dahlkemper / Jefferson County Commissioner candidate, Jeff Shrader / Jefferson County Sheriff incumbant, Tom Waldon / Jefferson County Coroner candidate, Todd Kastetter / State Representative House District 22 candidate, and Tina Francone / Jefferson County Commissioner incumbent.

Peggy Catlin, RTD District N incumbent, filled Tina Francone's vacancy 3 1/2 months ago. She knows that the service in our area is sparse but is trying to keep our current services. She has lived in Jefferson County for 34 years. She has a lot of transit experience including 11 years as the Deputy Executive Director of CDOT, in private business, involvement in the Union Station Project, and a Consulting business in Project and Engineering.

Casper Stockham Congressional District 1 candidate, is running against Diane DeGette. He ran 2 years ago and got 28% of the vote. He is trying again. He thinks that the black and Hispanic communities are underserved. On education, he said that there is a 40 - 50% drop out rate. He said that the teachers need more money. The economy is doing well, but not in the inner city. Teachers need to demonstrate how to get, keep, and exceed at a job. He is doing projects now. If elected, he will expand them. Other issues that he supports are empowerment, empathy, and doing a better job with the elderly and disabled.

George Stern, Jefferson County Clerk & Recorder candidate, has been an Attorney Business Consultant and Firefighter. He wants to make sure that local government is working for their community. He supports innovating and modernizing.

He wants to modernize the DMV. He wants elections to be secure.

Annette Cannan, Jefferson County Coroner candidate, has lived here for 38 years. She is a registered nurse. She now works as an educator and is teaching research. She has a LOT of medical knowledge.

Scott Kersgaard, Jefferson County Assessor candidate, supports fair and accurate value. At this time 5% are appealed. He thinks this percentage should be reduced. He wants better communication. He has worked as a Realtor for 15 years. He took and passed his Assessor's test. He owns his own business.

Lesley Dahlkemper, Jefferson County Commissioner candidate, said that there are more than 570K residents in Jefferson County. He has been here for 23 years. One issue he sees is skyrocketing house prices. He is a proponent of Open Space. He thinks we should preserve it. We have a thriving economy which includes the following industries: aerospace, aviation, beverage, outdoor activities, and mom and pop shops. He thinks that public safety is important. He has a family justice initiative to combat abuse and neglect for children and the elderly. He owns is own business.

Jeff Shrader, Jefferson County Sheriff incumbent, said that he has no opponent. In the Jefferson County Sheriff's Department, there are 571 deputies, 254 staff members, and 250 volunteers. In the county jail, they have about 2,000 bookings. Of those about 300 bookings per month have opioid dependencies. In May, 2018 there were 445 people with drug issues. And this reflects what is going on in the community. Deputies now carry Narcam. They have saved 3 lives this month. They provide Moral Reasoning training. They are hiring deputies. On Aug. 25 they will have the 2nd Annual Cops with Classic Cars.

Tom Waldon, Jefferson County Coroner candidate, has been an investigator since 2012. He said that the Coroner needs experience, needs investigative skills, and needs to be timely and accurate. There are about 13 deaths every day. The Coroner needs to determine the manner and cause of each person's death. He has experience as a Paramedic and oversaw 45 EMTs. He has been a small business operator. He was a Deputy Coroner. He is certified by the Coroner's Association. He worked on the Mass Mortality Plan. He supports suicide prevention and child brutality prevention. He asked for our vote.

Todd Kastetter, State Representative House District 22 candidate, said that he has never ran for an office before. He has been a small business owner. He now works in Trust Estates and Elder laws. He is a lawyer. He has lived in Jefferson County for 26 years. His focus is on achievement. Laws affect businesses, lives, and our community.

Tina Francone, Jefferson County Commissioner incumbent, is the incumbent. He is a wife, lawyer, and small business owner. In 2014 she was elected to the RTD District N position. In January 2017 she filled the vacancy left by Don Rosier. She believes that strong leadership is needed at the county level. She wants us to let her know what we think is good and what needs improvement. The commissioners are currently reviewing housing and County Planning. The budget needs to be streamlined with a look to our priorities. She supports the completion of the Jefferson County Parkway. Issues include potholes, curbs, gutters, and bike paths. She is a small government gal. She asked for our vote and contributions.

*From* **President's Corner**— We had a board meeting on July 10th. Thanks to all the board members and staff for attending and a special thanks to two homeowners for attending and sharing their thoughts. They were Darlene Fraser who has been a resident for 35 years and Sarah Bailey a new resident.

Please plan on attending the Movie in the Park and all the festivities on Thursday August 9th from 6 to 10 pm. It should be a great time with food trucks and a shaved ice truck. There will also be a band, yard games, popcorn, and glow sticks. The glow sticks will be sold by Coronado Elementary for the new playground initiative. Lots of fun will be had by all. Something we should ALL be aware of is the temporary Fire Ban by the Jefferson County Sheriff's Office whether it be for a recreational event or just around our own homes. A fine of not more than \$600 can be issued if you violate the prohibitions and are convicted. Basically, ONLY devices that are liquid fueled or gas fueled are allowed. Simply put, gas grills, gas fire pits, gas stoves, and gas lanterns are allowed. The rule of thumb is whether or not the fire can be "turned off" rather than "put out." Prohibited items are charcoal grills, tiki torches, fire pits, sky lanterns, chiminea (a freestanding front loading fireplace with a vertical chimney), fireworks, smoking (except within an enclosed vehicle, building, or designated smoking area), trash burn, chain saw without a USDA or SAE approved spark arresting device, and other torches such as a welder. So please be very, very careful not to make a mistake and start a fire by being careless. For more information go to https://www.jeffco.us/528/Fire-Ban-Details.

A lot of yards are still looking good even with the stress of the heat and rabbits eating holes in the grass. Keep up the great job of making our neighborhood look in tip-top shape. My normal reminder of course is please place your trash containers out of sight within a day after your waste company picks up your trash.

*From* **July 10, 2018 Board Meeting Minutes** President, Bob Haberkorn called the meeting to order at 7:02 pm. Board members Bob Haberkorn, Debbie Opperman, Bob Pellegrini, Steve Kalney, Joshua Kunkal, Pam Horiszny, and Chris Reynolds were in attendance along with Roger Borcherding of DARCO Property Management.

Treasurer's Report: Debbie reported the HOA currently has 349 members.

**ACC Committee:** There were approximately 30 new requests. There is one outstanding ACC Committee request to expand a garage (waiting to get more information such as drawings/designs. Josh to follow up.) We will add Steve and Josh's phone numbers to the newsletter to ensure people can call if they have questions. Bob P. suggested that he is ready to resume as lead on ACC Forms. Josh and Steve will resume their roles as support and provide second opinions as needed.

**Management Report:** Three inspections were conducted in June. Thirty-nine (39) Notices were issued. There were 16 RVs stored in view: 9 campers, 6 boats, and 1 trailer. Two houses need paint: 1 the garage door and the other the frame above the garage door. Ten lawns had dry grass (all have been corrected); 3 lawns had spots with bare dirt which are in the process of being corrected; and 4 properties had weeds in rocks or flower beds (all have been corrected). Two properties had a dead tree. One corner property had a large bush obstructing the view of oncoming traffic which has been corrected. There were six property sales in the last month and three properties currently for sale.

Welcome Committee: Jennifer Blake and team delivered five welcome baskets in June. Baskets include gift cards from vendors in the neighborhood.

**Social Committee:** Amy Kowalski said they were on budget for the Bike and Car show. Next year they are considering Sunday afternoon to drive more participation and adding motorcycles to the car show. They will also get two bouncy houses.

The Movie in the Park will be on Thursday August 9th. Voting for the movie has started (on Nextdoor). It will start around 6pm with the movie playing around 8:30-9pm. We are expecting 1-2 food trucks, shaved ice, popcorn, yard games, and a band.

Note about Garage Sale – we had very low participation this year. Some thought it might be because other communities do their sales at the same weekend. Considering changing to a week earlier or later.

**New Business:** We had a request from a homeowner for help with rabbits that are damaging the lawns. Suggested calling Jefferson County animal control for advice.

Josh contacted the County to discuss a dangerous Tree/Fence on the corner of Carr St and W Moraine street. Awaiting feedback from them and will keep us posted.

Barb suggested that the Board members could provide articles for the monthly newsletter. Debbie will provide the next article (Trash Talk) as the first article.

The meeting was adjourned at 7:50 pm.

From Leawood Metropolitan Recreation and Park District Minutes July 11, 2018 The meeting was called to order at 6:39 PM at Leawood Park by President Kyle Sargent. Members present were: Directors Donna Snyder/Treasurer, Debby Baker/Director, Jennifer Dawe/Secretary, Linda Smith/Vice President and Dave Padilla/Parks Manager.

**Public Comment/Correspondence** – A Leawood resident (wanted to remain anonymous) attended the meeting to discuss a few items/concerns: 1) Will the new potential development at 5234 W. Leawood Drive become a part of the Leawood Park District? The project developer told Kyle that, yes, they intend to join our park district. Kyle has also submitted a letter to Jefferson County Planning and Zoning requesting that the development be required to join the Leawood Park

District. 2) Mowing of native grasses in Weaver Park. Native grasses are mowed 3 times a season, unless more is required. A mowing is scheduled for Saturday, July 14th, the 2nd of the season. 3) Thank you for work done on the concrete repair in Weaver Park!

Leawood resident Mike Armbruster also attended the meeting to discuss rentals of Leawood sports/athletic fields. Mike and the Board discussed costs, and reservations.

**Treasurer's Report** – Donna presented the Treasurer's Report. Invoices for the month include: Weston, Xcel, Denver Water, United Site Services (port-a-potties), Horizon, Waste Management, new Coyote signs, LCA (Rapporter) and Dave's invoice. Linda moved the Treasurer's report be received and bills paid, Debby seconded, and the motion passed without objection.

**Parks Manager Report** – Dave reported that several willow trees in Raccoon Park need trimming, and recently a willow tree fell over, completely blocking the path. Dave trimmed the fallen tree so that people could walk around it temporarily. Urban Drainage will remove the tree and trim the others on Friday, July 13th. Dave reported that the sprinkler boxes on the east end of Racoon Park have been repaired but will need to be replaced to keep the system running. He is also looking at adding a line to get water to newer trees. This would provide direct water for new trees as they are planted to replace trees as they die or are removed. Currently, watering by hand is required. Dave will continue to work with Urban Drainage to address tree concerns in Raccoon Park. He is also reviewing the wood sections on the concrete path to ensure safety.

**Old Business -** The Board asked Kim Holland, a landscape architect, to design a landscaping plan for the area around the signs at the far east wooden bridge in Weaver Park. Kim presented her landscaping design to the Board. Her design included many native plants that would be drought tolerant once established. Dave & Jennifer will work with Kim. The hours are posted in the pool rules, and we will send out an email blast with the revised pool hours once we get closer to the change. Please remember that when school does start, there will be a number of children traveling to and from school. Some of the older kids may be driving to school. Others are not as old and will be walking to school. It is important to note that pedestrians in the crosswalks have the right-of-way. Sometimes it is tempting to look away from the road for whatever reason, but with heavier than normal pedestrian and vehicle traffic that could have negative consequences.

We are moving forward with the Fremont Street project, and the Board expects that it will be completed within the next

few months. Some residents have indicated that it would be nice to have the restrooms refreshed. This fall, the Board will be exploring options for giving the restrooms a new look for the next pool season. In the spirit of serving the community, the Board is always open to suggestions of operational or community improvement. Please feel free to let the Board know of your ideas to improve our community.—James Meyer, President

Established by the Colorado legislature in 1969, UDFCD covers an area of 1608 square miles and includes Denver, parts of the six surrounding counties, and all or parts of 33 incorporated cities and towns. The UDFCD runs on a \$30 million annual budget with only 32 employees. Contracting out the work keeps overhead low, costs down, and ensures all the jobs stay local.

The UDFCD provides services related to floodplain mapping, flood safety, new developments, planning, design, construction, and maintenance for municipalities and residents within the UDFCD boundary.



**Purpose:** To establish criteria for the relocation of prairie dogs into Jefferson County.

Policy: Prairie Dog Relocation into Jefferson County

A. Introduction

- 1. The release of prairie dogs that have been relocated into the County requires a prior Resolution of the Board of County Commissioners (BCC) approving the release. C.R.S. §35-7-203.
- 2. Prairie dogs are present on many properties in the County including several Jeffco Open Space Parks. The County has very few remaining sites suitable for prairie dog relocation.
- B. Criteria for Prairie Dog Relocation and Release into the County
- 1. In addition to such other conditions the BCC determines are appropriate, BCC approval is subject to the following requirements.
- a. Prairie dog relocation is necessary because the current site is over carrying capacity and denuded of vegetation.
- b. Adjacent property is adversely affected because the current site exceeds carrying capacity.
- c. The proposed new site is suitable prairie dog habitat and has ample carrying capacity for additional animals.
- d. The relocation has been approved by the Colorado Parks and Wildlife Commission and the owner of the new site.
- e. The relocation is in accordance with all applicable federal, state, and local laws and regulations.
- f. The relocation and release of prairie dogs into the County complies with C.R.S. §35-7-203.
- g. The requesting party has demonstrated that all relocation options outside of Jefferson County have been exhausted.
- C. Relocation of Prairie Dogs to Rocky Flats National Wildlife Refuge (Refuge)
- 1. In lieu of the procedures set forth in C.R.S §35-7-203, the County shall serve as a referral agency for requests to relocate prairie dogs to the Refuge from outside the County. As a referral agency the County will be provided the opportunity to comment on requests to relocate prairie dogs to the Refuge from outside the County before a request has been ap-

proved by the Refuge.

2. The County and the Refuge concur that permit applications to relocate prairie dogs to the Refuge from within the County shall have priority over permit applications to relocate prairie dogs to the Refuge from outside the County. From Jeffco website IRS IMPOSTER SCAM - DON'T BE FOOLED—District Attorney Pete Weir is warning consumers to beware of the IRS Imposter scam. While these scams are not new to the metro Denver area, the DA's Office is seeing an uptick in consumer calls about this, and similar, scams. There may be slight variations in the scams, but generally consumers receive telephone calls, voicemails, or emails from individuals saying they are with the IRS and that there is problem with the consumer's tax account. Callers may threaten a lawsuit, law enforcement, Treasury, or other enforcement action. In a variation on this, caller merely threatens legal or criminal action if certain demands for money or information are not met.

These scammers may be "phishing" for your personal and financial information, or they may demand some form of payment. Often the calls are made by computerized voices

Do not be misled. This is a scam. The IRS will never contact a taxpayer by telephone regarding their tax account. Consumers should hang up and not return the call. In addition, law enforcement or other government agencies will not contact you by phone or email with threats or demands. Payment, or your personal or financial information, provided to scammers cannot be recovered; often there is nothing that law enforcement can do.

"Scammers may employ threats in their attempts to convince consumers that this is an urgent matter and that they must act immediately," said Weir. "We encourage consumers not to react. When in doubt, always call your local DA or law enforcement agency for more information.

Should consumers receive one of these calls, we recommend they get more information before they act. Helpful recommendations and resources include:
