The meeting started at 6:05 p.m.

Diane Suchomel, Vice President, welcomed everyone.

Commander Mike Daly from Jefferson County Sheriff's Office was present.

No one from **Jefferson County Public Schools** was present.

Tonight's speaker was Commander Mike Daly from Jefferson County Sheriff's Office.

Mike has served since Jan. 2002. He has worked in all Divisions. He worked in SWAT, SORT, and Crisis Intermediation Core Team. SWAT handles incidents outside of the Jail. If an incident is in the Jail or Court House, it is handled by SORT. He has a Bachelor degree in Psychology. He also has special training in de-escalation including recognizing types of mental issues and how to deal with different types. He spent 12.5 years on patrol. He was promoted on June 12.

A new program called Fresh Start was released last week. It helps people on probation who are not following rules to get back on the right path. It also helps people with a warrant. It is only for low profile crimes. It is not for felons which includes assault, 3 or more DUIs, unlawful sexual contact, or domestic abuse. It is for minor fights, traffic warrants, or brothers fighting. There are 12,030 traffic warrants of which about 6,600 are probably still valid. It gives people a way to clear their name. They can have a court appearance that day or get a new date. They can also talk to their probation officer. The point is to keep them out of Jail. That way Jail could be for more violent people; people who could harm themselves or others. This may have been caused by COVID-19 restrictions. If they make a new court date and do not show up, they will have a new warrant issued for their arrest and may end up in Jail this time and cost more. Fresh Start was initiated by the Judicial System. (Update: Diane saw a notice on the JCSO website that 50 people who have warrants in Jeffco or Gilpin County went through that Fresh Start system at the Fairgrounds.)

Crime mapping is no longer working. The third party system vendor went out of business. They are looking for a new vendor.

National Night Out was August 3rd. They went to 11 HOAs. They would like 100 subdivisions to participate next year. In the last 5 years, motor vehicle thefts have gone up by 250%. They arrested 2 people last week. Unlocked vehicles are

the easiest target. About 60 - 85% of the cars are unlocked. **Please Lock Your Cars** and don't leave stuff in your car. They need about 45 more people hired. Part of the issue is retirements.

Their response time is pretty good. It is 6 min. 12 sec. for Level 1 and 2 calls.

Columbine Knolls South II Review

From President's Corner— Hello. We held our most-recent HOA board meeting in early July, and it went well with 6 of the 7 board members present along with 6 member households. It's always great to have community participation at the meetings. Understanding your issues, concerns, needs and opinions is vitally important to the board for us to undertake projects and initiatives that are important to you. One issue we discussed was legislation recently signed into law by Governor Jared Polis. House Bill 21-1310, which takes effect on September 7th, states that associations shall not prohibit or regulate the display of flags and signs on the basis of their subject matter, message, or content; except that the association may prohibit flags and signs bearing commercial messages. Furthermore, it reads, associations may adopt reasonable, content-neutral rules to regulate the number, location, and size of flags, flagpoles, and signs. Whether you support this law or not, our HOA will follow this legislation.

COMMUNITY EVENTS: I wanted to report back on the E-Cycle and Document Shredding event we held on July 10th. We had no idea what to expect in terms of turnout as this was the first year for this event. I have to say it was a HUGE success with nearly 100 members offloading items to be e-recycled and/or documents to be shredded. We ended up collecting 4,550 pounds of paper and 4,368 pounds of technology recyclables. We're still waiting to find out how many TV's and LCD monitors that was, but I can tell you it was a lot! I want to thank board members Chris Reynolds and Andi Elkins for spearheading this event. I would also like to thank Anita Schicktanz, Jim Reynolds and Bob Haberkorn for helping out. We're already working on ways to make this event even better for next year by exploring the idea of adding a hazardous waste (paint, household chemicals) component in lieu of or in addition to the e-cycle/shredding. I'll report back as the plan for next year takes shape.

We also received good news from Jennifer Blake that the Movie & Music in the Park event is returning this year. This event is a joint effort between our HOA and the Coronado Elementary PTA. The event will be held on Friday, August 20th Look for more details on our website (cksii.org) and on Nextdoor.

COMMUNITY PROJECTS: We recently received an update from Foothills Parks & Recreation on the installation of the

park light at the Coronado Park entrance near Nichols and Ammons streets. The pole for the light has arrived and the LED lighting components are supposed to land in Denver in the coming weeks. The goal is to begin the installation in late-summer or early fall.

The shade structure project is also moving along. The materials have been ordered and the contractor for the installation has been selected. The hope is to have the shade structure in place sometime in the late-summer or early fall. In closing, we are looking for HOA members to join the board and our various committees. From A Moment With The Board The July Monthly meeting was at the Columbine West Pool pavilion at 6:30 p.m. Under dark skies it was challenging to keep our papers from blowing away. Its been exciting to see the Membership Meter continue to rise, we now have 340 paid Members towards our 350 goal. Its a modest goal considering there are almost 1,500 homes in the development. The dollars received are spent in many areas around the development. From Leawood Metropolitan Recreation and Park District Minutes July 14, 2021 The meeting was called to order at 5:45 p.m. by President Steve Wall. Members present: Debby Baker/ Vice President and Secretary, Donna Snyder / Treasurer, Ike Nelson/Board Member and Dave Padilla/Parks Manager. Wade Hancey attended by phone.

Public Comments – (1) Holly Roberts attended the meeting to give an update on yoga classes in Leawood Park on Saturday morning and Wednesday evening. Holly reported that 5+ people have attended the classes so far.

- (2) Ken Deshaies contacted Steve to report that thistles are growing in Leawood Park. He said that many of them had grown to 3+ feet along the fence. Board Response: The large amount of rain that we have received has given weeds a big boost in all parks. The weeds will be taken care of.
- (3) Tom Bryant reported a that debris had accumulated next to the bridge in Raccoon Hollar. Board Response: The debris has been removed.

Tom also reported 2 apparently dead trees in Weaver Park and 1 in Raccoon Hollar. Board Response: Dave will investigate it.

Treasurer's Report – Donna presented the Treasurer's Report, bills paid this month include Denver Water, doggie bag vendor, Waste Management, Xcel Energy, Liberty Waste Management, Weston, DBC (Sprinkler parts), Leawood Civic Association (Rapporter and 1 dumpster at Neighborhood Clean-up), Jeffco Planning (permit to repair bridge in Weaver Park), Rich Alarcon, Dave's invoice, and reimbursement to petty cash. Debby moved that the Treasurer Report be received, and bills paid. Ike seconded and the motion passed unanimously.

Parks Manager Report – All parks were mowed, and irrigation inspected, and doggie bags checked and replenished as needed. Weaver Park: The vandalized potty will not be replaced until November because of shortage of new units. A sprinkler valve vandalized in zone 11 replaced, however a main water line was broken and needs to be repaired. The irrigation system had to be shut down until the line can be replaced. Changed out valve and clock next to the planter. Bluegrass was fertilized and broadleaf control applied.

Leawood Park: Repaired two water lines in zone 4 that were broken by the fiber optics company running line along Pierce. An old brass valve was replaced with a new Rainbird valve in zone 5. Bluegrass was fertilized and broadleaf control applied.

Raccoon Hollar: The tree trimming project continues, if weather permits, should be completed by end of July. Urban Drainage came to assess erosion along the creek.

T.Track: Main irrigation water line break in zone 18. Will be repaired next week. Replaced damaged shut-off valve. Bluegrass was fertilized and broadleaf control applied.

Old Business – Weaver Park Bridge repair: Received Minor Flood Plain Permit. We can now proceed with the repair work

What to do with the Volleyball Area in Weaver: Dave will investigate the cost of removal. Discussion will continue at next meeting.

Mats under swings: Have 2 cost estimates, will make a decision next meeting.

From Notes From the Board —The July Board meeting was held on July 21, 2021. The Board held the meeting at the clubhouse with the option to participate remotely. It was nice to meet everyone in person. Hopefully, we can continue to keep "the virus" at bay and life will become more like it was and we can continue to meet this way going forward. As many of you already know, there were some recent adjustments to the temperature of the pool. The change was in response to the pool becoming terribly warm and, unfortunately, the initial changes had a greater than anticipated effect, resulting in some chilly swims. We now have the pool dialed in to 80 degrees and are seeing it rise only to about 82 degrees on very hot sunny days. Much better.
