The meeting started at 6:01 p.m.

**Diane Suchomel, Vice President**, welcomed everyone.

**Commander Todd Bliss, Jefferson County Sheriff's Department**, was present.

No one from **Jefferson County Public Schools** or **Foothills Parks and Recreation District** were present.

The scheduled speaker from Platte Canyon Water and Sanitation District had to cancel due to illness. She will be at the March meeting.

Our speaker for tonight was **Commander Todd Bliss**. He is 1 of 3 Commanders at the South Precinct, but they may be back to 2 soon.

Car thefts are running high. Vehicle trespass is high also. Denver and our area are the worst.

They are having new hires work with senior deputies after training. When they are on their own, they can still ask for help.

When you renew your license plates, you have to pay for back fees.

All accidents are investigated by Highway Patrols (CSP) except those on private property. They have had this contract in

place for a long time.

The Youth Academy is coming up on June 12 - 16. This is for kids the ages of 14 - 18. They will find out how our department works. The website is <https://jeffcosherriff.co/Youth2023>. Applications are due by May 24. If you have questions, contact Deputy Bruening at 303-982-1982.

Has the short-term rental had an impact on the Sheriff's Department? Cmdr. Todd could not say at this time due to lack of data.

**Reports from Officers** We do not have a President.

Roll Call was taken. We had 8 members present and had a quorum.

**Ray Moore, Treasurer**, said that we have \$780.69. Most of our costs are due to the PO Box. Do we need to continue having it? Yes.

**Cheri Paavola, Secretary**, was present. The minutes for January were approved.

**Diane Suchomel, Vice President**, was present. She will retire from being Vice President. She will continue attending all of the Board meetings.

On the disposition of property related to closing Jefferson county public schools, there is a very detailed document on the process and time line on their website. They have separated the properties into groups (or rounds) . Round 1 will start Feb. 9. On the website you can get information on the Jan. 19 meeting. (*Update: they changed the date for the announcement of Round 1 properties to March 1. Round 1 properties will be in Arvada or Westminster.*)

**Site Development:** 22-112105 is for 11552 W. Hialeah Pl. It is for a 7800 sq. ft. office/warehouse. It is on an undeveloped parcel that is southeast of Goodwill at Belleview and Simms. It will be adjacent to the auto repair shop.

23-102035 is for 9150 W. Cross Dr. It is for 282 apartments with 330 parking spaces in an above grade parking garage. It is where the Draft Sports Grill is.

23-102056 is for 6465 S. Kipling Way. It is on 1.71 acres. It is for a 3 bay instant oil change facility / commercial area. It is near the northeast corner of Kipling and Coal Mine.

**Pre-Application** 23-102131 is for 6609 S. Yukon St. They want to remove the existing car wash and build 6 single family homes that at 5052 sq. ft. each. It will have a common entrance off of S. Yukon St. It is in the Woodmar Square subdivision.

23-101363 is for 6859 S. Iris St. It is for Special Use. It is 21.47 acres along Dutch Creek trail. It is east of Kipling Pkwy. It is now a horse / goat barn property. The entry is no longer on the website. This may indicate that the application was incomplete and therefore deleted.

There have been no changes to the Planning and Zoning Short Term Rental policy. Although they took "coming soon" off of their website.

Foothills Parks and Recreation District has an election in May for Wards 1, 2, and 5. It is an email-in ballot. Each are running for 4-year term. The current positions are held by Bill Meyer, Ward 1; Michael Biekiewicz, Ward 2; and Phillip Trimble, Ward 5. Bill Meyer is term limited. There is a self-nomination form on the FHPRD website. You need to live or own property within the Ward to run for a board seat in that ward..

FHPRD should learn in March if they will receive a \$250,000 grant from Colorado Parks and Wildlife for the non-motorized Dutch Creek trail extension.

**State Legislature** SB-23-097 - A bill proposes to make motor vehicle thefts a felony charge plus some other changes.

HB-22-1151 - There are no details yet on Turf replacement. Only common area turf can be replaced with matching grants with water-wise plantings. It cannot be concrete, artificial turf, water features, invasive species plants, turf, etc. Details are supposed to be ready by July 2023. The entire bill is on the website.

A TV news segment stated State Farm and Progressive will no longer ensure some Hyundai and Kia models in some major cities, including Denver. The reason is that "they are too easy to steal". This is only on new policies according to Diane's agent on her Hyundai.

Diane just got her property tax bill; it was \$22.38 lower than last year.

Our next meeting is March 1 at Columbine Library. We will be electing officers. We need President and Vice President to be elected.

**Old Business** CPW - On the \$29 addition on license vehicle renewal, according to a TV news segment, in January only 28% of the renewals paid that fee. CPW has now asked the state legislature to \$2 million to cover the lost income.

**New Business** If you want to opt out of district for South Metro Fire, you need to do it now.

I would also like to thank Joe and Gayle Alcala (Mr. & Mrs. Claus), their sleigh drivers Andi and Eric Elkins, and South Metro fire Engine 19 who led the parade. I also want to thank Paul Peck for his years of service on the board. Unfortunately, Paul had to step away from the board due to work and family commitments. Paul was very helpful with his work on the Community Standards, roofing guidelines, and his service on the Architectural Control Committee. Thanks again Paul! I am pleased to report that Matt Lawicki was voted by the board to fill Paul's vacated seat. We are excited to have Matt on the board and look forward to working with him. Look for Matt's bio in the next edition of the newsletter.

Chris Reynolds (Secretary) graciously offered to write this edition of the President's Corner and I gladly took her up on the offer. She has written a very informative article below, based on her experiences and recent feedback from our community.

While Coloradoans frequently say "we need the moisture" our recent snowstorms have created some nuisances as well as some liability issues when it comes to snow removal. I've lived in CKSII for nearly 15 years and I'm happy to say most of our community members properly clear their sidewalks after a snowstorm. But I recently learned a few things about snow removal that I wanted to share. You might be as surprised as I was!

Do you know who is responsible for clearing the sidewalks along Carr Street? In mid-January, I went on a morning walk with my neighbor and her 10-year-old son. It was a cold clear morning and Jack was showing off his "big poofy jacket" as we walked him to school at Coronado Elementary. We are fortunate to live so close to the school but even so, when the sidewalks along Carr Street aren't properly cleared, kids must walk through the snow or in the road to get to school. (See the pictures of Carr Street from the south and north sides of the road.) My friend worries about Jack possibly stepping out into the street to avoid icy, snowy sidewalks, especially when Carr Street is so busy around school start and end times. We want our children safe when walking to school, which makes it so important for people to clear their sidewalks (shovel, snow-blow, salt). But who is responsible for clearing the snow from the sidewalks along Carr Street?

When researching the lot lines of the CKSII homes on the east side of Carr Street (using the Jeffco ASPIN map at <https://www.jeffco.us/2197/Address-Lookup>) we found their lot lines directly border the sidewalk. If a property line is next to the sidewalk, then that property owner is responsible for the snow removal (just as it is on the interior streets). This is particularly important because those sidewalks on the east side of Carr Street are school pedestrian routes and when they aren't cleared, children may have to walk in the street.

While the HOA has no jurisdictional control or authority over the Carr Street sidewalk, we are exploring options for the HOA to fund snow removal because it is a primary pathway for children in our community to get to Coronado Elementary. In the meantime, we ask for community support to keep those sidewalks clear.

Do you know that Colorado has a snow removal law? It states: 1. Residents are responsible for clearing driveways and sidewalks within 24 hours after a snowstorm to allow safe use by pedestrians. I guess I can't follow my usual practice of waiting for the sun to melt the snow in my driveway (unless it's within 24 hours)!

2. Owners must place snow from their driveways and sidewalks onto their front yard or other areas of their own property, and not into the street. I am guilty of directing my snowblower to blow snow into the street. I had no idea! From now on I will blow snow onto my yard because 1) it's the law and 2) free moisture!

3. Jefferson County postal regulations require residents to clear snow in front of mailboxes to allow for mail delivery.

As a community member, I am grateful to everyone who dutifully clears their snow. And hopefully this article provided new information about how we can all work together to keep our sidewalks clear and our kids (and community) safe!
