County information: Miscellaneous Permit: 24-110669 is for 4630 S. Wright Way. It is for a chicken coop. It is zoned as R-1B and is 22 sq. ft.

Site Development: 24-108421 is for 13420 W Coal Mine Ave. It is a minor architectural change for WalMart's exterior sign, painting and signage directing people to the auto repair area.

Special Event: 24-110188 is for 8501 W. Bowles Ave. It is for Do Portugal Circus in the main mall. They are estimating 225 spectators and 20 participants. It starts on May 20th at 7:30 - 10:00 p.m.

Diane tried to get a speaker on recycling. However there is good information on these company's websites: Best Buy, Home Depot, Lowes, and Rooney Road.

ADU (Accessory Dwelling Units) - The complaint is that the cost is too high for low income households. There have been many articles on this subject. The state wants zoning and higher density along transit corridors.

Foothills Park and Recreation District—They are working on the draft for an item for the November Mail Ballot. The current mill levy approval will expire next year; they want to extend it.

New Library—(They started with 63 location suggestions. Then they got that down to 15 locations. Now they have 5 - 6 locations. Schools are not on the location list. **Correction**: This information is for the new library in the mountains, not for the South Jeffco location.) They are meeting with the Board of County Commissioners in September.

County Commissioners will decide in June if they will ask for a Mil Levy issue on the Nov. Ballot.

Diane thanked Ray for helping with the Adopt-A-Highway project.

The entire drainage at Westbury Park has been spray painted. (update: Jeffco Rd & Bridge painted over almost all of it) Post Office stamp prices are going up in July.

From **President's Letter** — Hello CKSII HOA community, my name is Chris Reynolds and I am a Director for the HOA Board. I have been a member of the HOA for more than eight years and enjoy giving my time to the community in this way. This month, I am writing about recycling, which according to my family, I'm quite fanatical about. It's probably because I am constantly policing what gets put into the big green Waste Management (WM) containers because I know putting in the wrong thing can result in the whole contribution getting thrown in the trash. So here are a few tips I'd like to share with you! It's important that only the right items make it into the WM recycle bin – and they need to be clean – to ensure efficient recycling. There are three basic rules to recycling with WM:

RULE 1: Recycle bottles, cans, paper and cardboard. These have the greatest impact on recycling.

RULE 2: Keep food and liquid out of your recycling. Recyclables don't need to be spotless but should be clean enough to avoid contaminating other materials.

RULE 3: No loose plastic bags and no bagged recyclables. Plastic bags can shut down an entire recycling plant, so don't toss loose plastic bags into your curbside recycling bin and never bag your recyclables. Empty loose recyclable items directly into the bin. You can take plastic bags to Walmart or King Soopers for recycling.

Sometimes my family wants to recycle things that just don't go into the WM container:

Pizza boxes – yes, they are cardboard but if they have food stains on them, not to mention stuck-on toppings, they aren't recyclable.

Disposable cups from fast food restaurants – my kids are always putting their Starbucks and other cups in the recycling bin. The truth is most paper to-go cups cannot be recycled or composted because they contain a plastic or wax coating to prevent leaks.

Loose lumber – one time my husband put loose lumber in the bin. Just... no.

Waste Management's website (https://www.wm.com/us/en/ recycle-right) has a lot of helpful information about what they recycle but it really boils down to the three rules listed above.

There are some larger recycling centers not too far away that will take other items if you are really into recycling: Quail Street Recycling Center (1068 Quail St. in Lakewood) takes scrap metal among other things.

Rooney Road Recycling Center (151 South Rooney Road in Golden) recycles (or disposes of) household hazardous waste for a low fee (they are subsidized by our jurisdiction).

The City of Littleton offers great resources for recycling on their website (https://www.littletonco.gov/

Government/City-Services/GreenEnvironmentalPrograms/Reduce-Reuse-Recycle) including donating vehicles, yearround prescription drug take back services, and free wood mulch.

WM is pretty clear that if we put the wrong things (or dirty things) in the big green container, they won't sort it and it's likely the whole offering will end up the trash. But with a little effort, we can help ensure WM recycles the materials we give them and ultimately create a healthier planet for ourselves and future generations.

From **Notes from the March Board Meeting**—Happy Spring to all! Within a few weeks, the countdown to summer will begin and children will have visions of no homework in their heads. The pool has been fully serviced and we believe it is finally in full repair for many years to come. Over the last decade, we have replaced the pool surface, pump, pump motor, water heater and chemical regulation controls, and while extremely expensive and arduous, the 30-year pool maintenance items should finally be complete.

We've collected enough Simms St. fence repair quotes to approve a contractor and get those repairs completed in the coming weeks. As expected, it took an unusual amount of time to find fencing contractors who were willing to entertain repair services, as so many fence replacements were needed throughout the front range from the wind in early April. The large spruce tree next to the East pool fence has also been fully removed after its demise in the windstorm. We are consulting with Bailey Tree to entertain a replacement, but will likely need to wait at least a year to allow for the remaining roots to die off and allow the soil to accept another mature tree.

As usual, the work and coordination of the Woodbourne Easter Egg Hunt committee resulted in a hugely fun and successful hunt for all who participated. We look forward to other events this summer season – pool kickoff party, 4th of July parade, and the Wave-sponsored end of summer event. We are continuing to evaluate how we align possible sponsors to events to help keep Woodbourne-specific costs to a minimum.

The Clubhouse renovation phase 1 construction has either just been completed or will be completed as you are reading this note. The next step is to purchase furniture and other items to fill the space. Simon and his committee have gone above and beyond catering to schedule changes, vendor replacements and everything else that goes into a project, as all-consuming as this one has become. Their efforts are greatly appreciated!

Unfortunately, the HOA Annual meeting did not take place on April 16th. We were only able to attract 71 representatives from the neighborhood either by signed proxies or physical attendance, well below the 102 residents required for a quorum. The discussions we did still entertain covered many aspects of resident life: the fiber optic companies installing product, Chatfield students (and unfortunately some residents) speeding throughout our Woodbourne streets, and the possibility of resurfacing the tennis court. The Board is not required to conduct another in-person annual meeting, and since a re-print notice would be required and would cost over \$750, this is being viewed as unnecessary. There is also no assurance that we would attract the quorum of 102 attendees to conduct the meeting again, and as noted, we did already discuss many of the items that would be repeated in another formal setting. Sheryl Archuleta and Darrel Loyd have both extended their board terms, and we will be publishing new board titles in the next notes article and update them in future newsletters. We appreciate all residents continuing to submit ACC project forms and ensure they follow our covenants and regulations. We are expanding the ACC review committee and are still looking for volunteers. 
