**Jefferson County Information:** MVR 24-130058 is for 7736 W. Long Dr. It is for Bowles Crossing Apt II. They want a minor adjustment for reduction in parking spaces and they don't want to make the required setback for every floor. PA 24-128093 is for 9150 W. Cross Dr. There have been no changes. It is for a 4 story apt with 285 units and a parking garage with 431 spaces plus 34 outside parking spaces. This is at the old closed sports bar north of the SW plaza. Short Term Rental - No changes on the P&Z website.

The Corporate Transparency Act will affect many HOAs. Board members or anyone with financial oversight has to do a lot of paperwork by January 1. The information came from Altitude Law on the Federal Treasury website for BOI. It does not apply to all HOAs. It may be a deterrent to attracting new board members. The documentation is CTA and has 59 pages. 501C4 HOAs may be exempt. Incorporated HOAs may need to report.

The status for the new Library won't change until December.

Our next meeting is December 4. We will move the January 2025 meeting to January 8 due to New Years. A room has been reserved at Columbine Library for both meetings.

Someone is working on Homeless Awareness Task Force. It is about sheltering people.

Diane thanked Ray for helping with Adopt-A-Highway.

Leawood Metropolitan Recreation And Park District Meeting minutes of October 2, 2024: The meeting was called to order at 6:10 p.m. by President Kyle Sargent. Members present: Judy Anderson/Vice President/Treasurer, Carrie DuPree/New Member. Other District: Debby Baker/Secretary and Dave Padilla/Park Manager. Visitors:Leawood residents Carol Gottlieb and Wade Hancey.

**Board Member Resignation** – Kyle received an email from Maggie. She submitted her resignation effective immediate-lv.

**Treasurer's Report** – Judy presented the Treasurer's Report. The bills to be paid this month include Denver Water, Xcel, Weston, Doggie Bags, Waste Management, Honey Bucket, Blossom Tree, Dave's invoice, and reimbursement to petty cash. Weston, Honey Bucket, Denver Water, Dave and petty cash were paid by check. All others listed above will be paid electronically.

Parks Manager Report – All parks were mowed, inspected, doggie bags checked and replenished as needed. The sprinkler systems in all parks will be drained and prepared for winter in the next two weeks. Carol suggested researching new sprinkler systems with automated alerts for water leaks. (A) Weaver Park – Irrigation Zone 19, was over spraying onto the sidewalk. The 1-25 router needs to be replaced. The trees along the parkway and the tennis courts were trimmed. The split rail fence was repaired. (B) Raccoon Hollar – The debris pile was removed. (C) T Track – There was a break in the main waterline, it has been repaired.

**OLD BUSINESS**:(A) Document retention updates – Postponed because of Maggie's resignation. The Board needs to pick up the information that she has gathered and the work that she has done. (B) Accounting support and contract updates – The contractor has been unable to recover the information on Donna's DOS accounting program. We do have hard copies of the information. (C) Weed control updates – The scheduled fall weed control application for the blue grass has been completed in all parks. (D) Raccoon Park safety trims – Weston will begin the safety trims in the next two weeks and continue as weather allows.(E) Website – The Board will research other possibilities for a separate website for the District.

**NEW BUSINESS:** (A) Board appointments – With Maggie's resignation, three Board Members remain. Judy motioned that Carol Gottlieb be appointed to the Board. Kyle seconded. After further discussion, the motion passed unanimously. Carol was sworn in and will serve until the next election in May of 2025 when she may run for a new term. Welcome Carrie! (B) Discuss potential 2025 projects – Each Board Members will put together a list of potential projects that they would like to pursue. The lists will be discussed at the next meeting to determine a final list of 2025 projects. The projects and their estimated costs will be used in the determination of the budget for 2025. The budget will be discussed and adopted at the December meeting. (C) Review By-Laws - Postponed due to time constraints.

From Notes From The October Board Meeting —Happy Fall! As the weather changes and leaves start to blow, we wanted to share the current state that both the board and the neighborhood will be experiencing in the next few weeks/months.

The clubhouse: the second phase to refresh the restrooms will be a topic of conversation in future months. We are also transitioning from Xfinity Broadband to BAM Fiber Wi-Fi. We will save \$100 a month for a much stronger and reliable bandwidth speed.

The pool: we lost our heater last year in the mechanical room and experienced a burst pipe during the extreme cold snap in January. We are installing a replacement and are currently obtaining formal quotes for a heating solution replacement, so we can have that installed in late November/December, before the winter officially settles in. There are 3 issues that were found as part of the pool shut-down this season

that will need to be addressed during the pre-work to bring the pool online in the Spring of 2025. We have quotes for the work and will schedule with the vendors as the comeback online in early 2025.

The fencing surrounding the pool and rock wall on the South and East sides of the pool: we are working with both fencing and landscaping vendors to assess what we see visually as concerning and what we may not see and how to ensure we are keeping our common assets safe, secure and are proactively ensuring we address issues.

Please look for a letter regarding the Woodbourne Community 2025 Budget. The board has reviewed and approved the budget and will put it up for formal ratification during our November meeting (November 13). We project no current need to adjust fees, and we have signed some longer-term contracts with our providers to ensure we can retain labor costs and services increase for the next 3 years. Now that inflation is slowly coming down and we have some stability post-Covid, we are seeing more normal operating models for our providers.

We also are negotiating with our neighborhood management company ACCU. The Board will be making a concerted effort, now that we have experience and visibility into how we best interface with ACCU as to how we can ensure we always look for ways to enhance that relationship. We have received some feedback from residents as to specific areas of individual dissatisfaction with ACCU processes, communications, portal requirements, etc. We will use early 2025 to ensure that we collect, prioritize and present to Sr ACCU management of our concerns and look for ways to complement our services. If you have any questions or issues that would like to be part of those discussions, please forward those to either Errin or Sheryl's Woodbourne email addresses. Please provide factual details, trying to remove emotions where possible. We are trying to look for trends, repetitive issues and/ or future opportunities to make our working relationship as smooth as possible.

Lastly, we have decided not to pay \$1,400 to have our neighborhood holiday decorations professionally installed by Keeson, so we will be seeking quotes from residents willing to take that process over.

We wish everyone a healthy, happy and relaxing start to the Holiday season and really appreciate the trust you give to our members in ensuring we best represent and serve all 407 homes in Woodbourne. —Your Woodbourne HOA Board

Simms Street Reopens For Public Travel After a Yearlong Closure —Simms Street was realigned between 112th Avenue and Colorado Highway 128 to enhance street connectivity and facilitate development as part of the Verve Innovation Park development. The new alignment includes a three-lane roadway, enhanced streetscape, sidewalks and additional intersection capacity at Highway 128 and Eldorado Boulevard.

Jefferson County Weed of the Month: Tree of Heaven — Tree of Heaven is native to Asia and was introduced to North America in the 1780s as an ornamental. It has escaped and is now also found infesting waste places, abandoned property, riparian areas, rights-of-way, and more commonly in urban areas.

Control includes herbicide treatment of stems (basal bark or hack) and foliar treatment of small plants. The time for control is mid-summer through fall. Removal and cut stump treatments often result in resprouting and are not recommended. https://www.jeffco.us/795/Invasive-Species-Management


